

t was on a blazing yet sultry afternoon on May 26th, 2022 that Shri Vinai Kumar Saxena took oath as the Lieutenant Governor of Delhi. The events that followed that day and few subsequent days, unknowingly set the agenda for the endeavours that followed.

Shri Saxena, who had described himself as the "Local Guardian - LG" of Delhi immediately after taking over, took the officials of the Raj Niwas and the Secretariat by surprise. Instead of customary ceremonials, the new LG right after taking over, went on an inspection visit of the stretch of road from Dhaula Kuan to

the IGI Airport. Having become used to it, none till then had realized that these portals of the National Capital were in a pathetic state of neglect. He passed on-site instructions for cleaning, revamp and beautification of this stretch that saw millions commuting to and from Delhi.

The next few days were again, probably unprecedented. The Lt. Governor accompanied by top officials visited the entire 57 km stretch of the Najafgarh Drain, the mountain of garbage at Ghazipur, the Construction & Demolition (C&D) Waste dump site on the Yamuna floodplain opposite Sarai Kale Khan, the Bhalswa

Lake and Landfill Sites, the areas adjacent to the Jailorwala Bagh jhuggis, the Asola Bhati Mines and the historical Roshanara Bagh amongst others.


These visits were not planned exercises after official briefings. These were spontaneous reactions of a person, who had seen Delhi during his over six years of stay in the city as the Chairman of Khadi & Village Industries Commission (KVIC).

All in themselves were long existing visible thorns that had been left unaddressed and removed out of public attention by a consistent effort of glossing over, by means of hyped campaigns and propaganda.

It was with single mindedness that the Lt. Governor thereafter took upon the task of addressing these issues and consciously brought the then government of GNCTD in loop for every endeavour that he undertook. What followed in terms of results and the attitude of the then government is a matter of record in public domain.

Even as the city started changing, bit-by-bit, despite opposition from entrenched political quarters, the biggest issue that came out of the churning caused by the LG's endeavours, was the pathetic state of civic infrastructure in Delhi and institutional lethargy of various bodies.





Away from the comforts of the Raj Niwas, the "local guardian" of Delhi was invariably on roads every day. Visits to slums, unauthorized colonies, villages and decaying heritage sites brought to the fore, hitherto hidden aspects of Delhi.

None would have imagined that the Capital of India would have grave issues of sanitation, water availability, roads, drains and health, even worse, probably than any tier-3 town in the hinterland. After every visit, the LG flagged these issues and requested the government or the agencies concerned to work towards addressing them.

The biggest outcome of these endeavours, was that issues that were away from public glare lying hidden due to a systematic diversionary propaganda campaign, came out in the open and started getting addressed. It forced the powers that be to take these issues up on their agenda.

Similarly, while the LG could only do as much with agencies like Delhi Jal Board, PWD, Health Department and DUSIB, etc. them being transferred subjects, he brought about an unprecedented change in DDA, which was directly under him. Shaking itself out of inertia, the agency achieved a total turn around in terms of its functioning and finances.

The development of the Narela Sub-city, in the limbo for decades, took a giant leap, civic infrastructure in Dwarka Sub-city received a major fillip. Sale of DDA houses resumed and the PM-UDAY lying dormant for years began taking shape, bringing much relief to the unauthorized colonies of the Capital.

Other focus areas were permanent employment against adhocism, skilling, Ease of Doing Business by rationalizing the licensing regime, crack down on drugs and a concerted drive against illegal immigrants living in the city. Each saw successful endeavours that remain a work in progress.





Streamlining of governance by establishing seamless coordination between various arms of the State, that included Government of India, Government of NCT of Delhi, urban local bodies and the neighbouring states remained high during the last three years.

Unnecessary litigation was discouraged, court matters were settled and the biggest test of inter departmental coordination came in the shape of successful revamp of the city before the G-20 Summit.

Not only was the Lt. Governor on the streets with the people, but in a pioneering move, opened the Raj Niwas to ordinary Delhi residents through an open forum for interaction, in the shape of "Samvaad". Thousands in groups and individually, got to interact with the LG directly.

The past three years have been about venturing into unchartered horizons. They have been dedicated to Bringing the Issues of People to the Fore, Racing to Restore the Yamuna, Striving for a Sustainable Habitat, Restoration of Delhi's Heritage, Cleanliness and Adorning the City Bit-by-Bit.

As we complete three years, we look forward with hope. We look forward to a city that deserves being the Capital of our great Nation.






















III. RESTORING THE FLOODPLAINS - REJUVENATING THE YAMUNA


V. RENAISSANCE OF DELHI: MAKING IT THE HERITAGE CAPITAL!


The Tomars brought the Hindu rule to Delhi, which eventually got passed on to the British after witnessing the eras of Delhi Sultanate and Mughals.







Heritage Structures, Water Body Revived In Delhi Archaeological Park. LG Says More

VII. EMBELLISHING THE CAPITAL



VIII. INDIA HOSTS G-20 SUMMIT

ven as the Nation got ready to host its biggest multilateral event after the CHOGM and NAM Summits in 1983, in the shape of the G-20 Summit - 2023, Delhi remained thoroughly unprepared, thanks to the apathy of the then city government. What made the situation alarming was the unprecedented flooding of the city barely a month before the Summit.

Multiplicity of governance authorities coupled with an apathetic city administration called for urgent intervention. It was at this stage that the LG took over the charge of getting all together and delivering in a seamless manner.

The spectacle that the Nation witnessed during the Summit on 9-10 September, 2023, did not emerge out of meetings in airconditioned chambers. It took a lot of hard-work on ground and the LG led from the front.

Be it repair of roads, coordination between agencies under the Government of India, Government of NCT of Delhi, the Municipal Bodies, adornment of the city with flowers and artefacts, maintenance of law & order or clearing of waterlogging at Rajghat, where all visiting dignitaries paid their respects, the LG led teams on the ground.

IX. NO BLAME, NO GAME JUST TAME THE MOUNTAINS OF SHAME

s the constitutional administrator of Delhi and with the three separate municipal corporations of Delhi in the process of unification, pending elections, that were held eventually in December, 2022, the LG set the ball rolling for achieving the unthinkable - clearing the three mountains of municipal solid waste at Ghazipur, Okhla and Bhalswa. On ground initiatives and innovative measures for bio-remediation of the accumulated garbage, undertaken under the LG's direct supervision, led to dramatic results. Disposal which stood at 4700 MT per day till May 2022, has gone up to over 25,000 MT per day at present.




TOTAL LEGACY WASTE DISPOSAL


3 yrs (2019-20 to 2021-22) VS 3 yrs (2022-23 to 2024-25)


AVERAGE MONTHLY LEGACY WASTE DISPOSAL



On the advice of Hon'ble LG, Refuse Derived Fuel (RDF) from dumping sites were, for the first time, tested for Gross Calorific Value (GCV) to ascertain its utility by industries using coal/oil in Delhi's neighbourhood. Upon finding the GCV to be suitable at a minimum of 2500-2800 Kcal, MCD offered it to industry as a viable alternative. Earlier, MCD used to pay a substantial sum of Rs.1765/MT to the concessionaires for lifting RDF from its landfill sites, but with the new initiative, MCD has successfully saved huge costs besides getting rid of the legacy waste at a faster pace.



X. REVIVAL OF SAHIBI RIVER AND YAMUNA REJUVENATION: INFUSING LIFE INTO A DEAD AND DYING RIVER


ealizing that the main source of pollution in the Yamuna was the sewer and garbage flowing into it through the numerous drains of the city, the Hon'ble LG took upon addressing the malice at source from day one. These efforts, to begin with, focussed on cleaning the Najafgarh and Shahdara Drains, which account for nearly 85% pollution in the river. Apart from this, he also took upon himself to clear and restore the floodplains, which were another source of pollution in the river. Visible results in terms of cleaner floodplains and relatively improved BOD / COD levels led to the National Green Tribunal (NGT) appointing the LG as the Chairperson of the "High Level Committee for Rejuvenation of the Yamuna" - a role he steered for five months, before the city government approached the Hon'ble Supreme Court and got the NGT order stayed on 11.07.2023.



Cleaning of Najafgarh Drain

Najafgarh Drain is 57-km long with as many as 132 smaller drains discharging sewage into it. The annual silt deposit in the drain is to the tune of 2 to 2.5 lakh cubic meter and at present approximately 85 lakh cubic meter of silt is deposited in the drain. On 04.06.2022, the LG made his maiden visit to the Najafgarh Drain and took up the cleaning of the drain in Mission mode. For the first time on 13.08.2022, Hon'ble LG entered the Najafgarh Drain in a motor boat to assess the prevailing situation and, accordingly devise scientific ways to overcome the legacy challenge.












Partial Gravitational Desilting for Cleaning of Najafgarh Drain

The first ever scientific operation to rejuvenate Najafgarh Drain (57 KM) by cleaning and desilting the drain through a costeffective scientific concept of Partial Gravitational De-silting process was initiated. This sustainable and cost-effective cleaning measure ideated by the Hon'ble LG, comes from his past experience of dredging in the ports of Gujarat. This technique uses the flowing water in the drain itself to take the silt away by loosening and churning of the silt instead of physically removing it, as was being done till now. Churning of the thick silt deposit is being done with the help of non-conventional floating equipment and contraption modified with raker and spikes attached to the boats. The modified equipment are dragged inside the drain by the boat and they, in turn, churn and loosen the silt. Subsequently, the loosened and suspended silt is taken along by the flowing water, thereby effecting natural de-silting.





XII. MINIMUM GOVERNMENT, MAXIMUM GOVERNANCE

In line with the Hon'ble Prime Minister's dictum of "Ease of Doing Business", the LG brought about much-delayed reforms in the licensing processes, increasing hours of businesses and in the process not only creating further revenue for the State and enterprises and employment for the people, but also providing Delhi with the hitherto missing night life.



XIII. STREAMLINING AND OPTIMIZING GOVERNANCE

iven the unique position of Delhi as the National Capital and a Union Territory with a Legislative Assembly as also three different Urban Local Bodies, the Lt. Governor of Delhi, who is also ex-officio Administrator of the UT, has a special role, unlike any other in the governance structure.

Despite challenges, the LG tried to establish seamless coordination and unity of purpose in various arms of the State that include, the DDA and Delhi Police, which come under his direct ambit as reserved subjects, the Urban Local Bodies and the Departments and agencies, which fall under the realm of the GNCTD as transferred subjects.

The major endeavours in this sphere included striving for corruption-free land revenue administration, ease of registration procedures, zero tolerance to drugs, drive against illegal immigrants, cutting down unnecessary government litigation, speedy disposal of cases under the LG's quasi-judicial powers, record persecution under the Passport Act and record permanent government employment following due process.















Recruitments done by DSSSB from 2012 to 2025










Personnel Reforms

With the view to ensure promotional avenues for serving Government employees, improving their service conditions and creating positions in government that are relevant to the contemporary demands, Hon'ble LG initiated the revision of Recruitment Rules (RRs) in several departments of Delhi Government and other Government agencies. This revision that is supposed to be done periodically, had been pending for decades together. As a result of this initiative, as many as 76 RRs in various departments have been amended and a thorough overhaul is underway.



Crackdown on Illegal Immigrants

Hon'ble LG came down heavily on the menace of illegal immigrants in the City. Often associated with heinous crimes and eating into the limited resources of the state, such immigrants had long been an issue of concern. Concerted action under direct supervision of Shri Saxena resulted in an almost 90% increase in identification and deportation of such immigrants.

XIV. TOWARDS SMART VILLAGES

ot many would know that Delhi, the Metropolitan Urban Agglomerate has a huge rural component. Hundreds of villages upon whose land Delhi came up. Lying mostly in the neighbourhood of posh colonies, swanky markets and upmarket localities, the residents of these villages, who once owned Delhi, were living in deplorable conditions, thanks to the utter neglect of the then city government.

Absence of basic civic infrastructure like roads, drains, parks, water supply, basic health facilities and even cremation / burial grounds, had turned these villages into ghettos of unorganized urbanization. The LG, who had first got exposed to the plight of these villages while working in a few of them as Chairman of KVIC, took up the task of transforming them in mission mode. He first got the Gram Sabha Land, originally belonging to DDA, back to DDA and simultaneously getting the tied development fund of Rs.960 Crores transferred from Delhi Government to DDA.

Thereafter, began the exercise of civic transformation in these villages. DMs alongwith their teams, were directed to camp overnight in these villages, interact with villagers and come up with the projects according to the needs of the residents. This resulted in more than Rs.800 Crores spent on various projects in less than an year.




XV. RE-ENVISIONING THE SUB-CITIES NARELA, ROHINI, DWARKA


t was with the futuristic prospective vision that DDA had planned and launched, the three sub-cities Rohini, Dwarka and Narela. However, all three, especially Rohini and Narela failed to achieve desired results. Lack of adequate civic infrastructure and connectivity to other parts of the city resulted in sub-optimal utilization of these huge planned urban spaces.

Hon'ble LG initiated a concerted drive to improve infrastructure in these areas and their connectivity to other parts of the city. The efforts included development of roads, drains & streetlights, augmentation of water supply, sufficient policing and enhanced connectivity by rationalizing bus routes and expediting the long-pending Rohini-Bawana-Narela-Kundli Metro Project. The areas got further boost with the Hon'ble LG singularly driving the development of an education hub in Narela and commercial development in Rohini and Dwarka in the shape of office complexes, hospitals, five star hotels, sport stadia and a Gold Souk.




XVII. A DECISIVE RECLAMATION DRIVE

very monsoon, the National Capital presents shameful scenes of waterlogged streets, crawling traffic and even human casualties. To top it all, inundation even at the Indira Gandhi International Airport caused international embarrassment for the country fast emerging as a world leader. All this was a result of lack of an upgraded drainage plan and something as avoidable as silted drains that were not cleaned for years together.

The LG took up the rectification of the drainage system at the IGI Airport in a mission mode with construction of Trunk Drains that not only solved the issue of inundation at the Airport, but also in the neighbouring Dwarka sectors. Despite restraints, he also undertook the de-siltation of drains in the city by bringing together every agency tasked with the responsibility of cleaning these drains.






Airport Drain

Airport Drain is a major drainage project to channelize the rain and storm water discharge from the IGI Airport and thus prevent waterlogging in and around the airport and the Dwarka area. The project has been executed by DDA under guidance of Hon'ble LG. The airport drain can discharge 70 CuM of water per second during the peak rains. The drain starts from inside the IGI Airport premises, passes beneath the Railway tracks adjoining the airport boundary in Dwarka Sector-8 and connects to DDA's Trunk Drain - 2 (TD-2) that would further channelize the rain water to Najafgarh Drain. The project was stuck for over two years pending permission for translocation of trees / afforestation.












XIX. TACKLING DUST POLLUTION

ir pollution is the severest health hazard that the residents of Delhi face. Every year, it gives negative headlines to the National Capital. While much is said about pollution caused by vehicular emission, it was the LG, who took cognizance of the fact that about 40% of the air pollution in the city was on account of dust that was generated domestically, with 56% contribution to PM10 and 38% contribution to PM2.5 level, as per various studies by IITs and DPCC etc.

Realizing that controlling dust was the easiest measure that had been left unaddressed for years together, the LG undertook a concerted drive to mitigate dust from the roads, dried silt from drains and kuchha footpaths / sidewalks. Apart from leading an exercise for removal of dust by various agencies concerned, the LG also introduced the novel measure of placing rotating water sprinklers on high rises across the city. He also directed the DDA to install such sprinklers on streetlights at an appropriate height in Dwarka. These sprinklers not only reduced dust but also helped combat heat. The success of this exercise led to the same being replicated in the NDMC area.



XX. TURNAROUND OF DELHI DEVELOPMENT AUTHORITY

aving remained in red for over a decade, the Delhi Development Authority posted an impressive surplus of Rs 1371 crore at the end of financial year 2024-25. This was the second consecutive year when DDA recorded revenue surplus. In 2023-24, DDA had recorded a surplus of Rs 511 crore under the General Development Account (GDA), thereby reversing the revenue deficit trend for 12 consecutive years. DDA's massive surplus was primarily on account of the unprecedented sale of housing units across all categories at various locations under the guidance of Hon'ble Lt Governor, Shri VK Saxena.


When Hon'ble LG took charge in May 2022, the DDA was incurring huge losses mainly due to huge unsold inventory of DDA flats. In the very first Authority meeting that he chaired after taking over the reins of DDA, Saxena took strong exception of the consistent losses and asked DDA officials to take corrective measures to curb the losses and make DDA financially self-sustainable. However, since then, DDA started working in a mission mode under Shri Saxena's guidance and introduced a host of innovative initiatives and people-friendly measures that resulted in a complete turnaround of the agency.







Growth Trajectory of DDA Finances(General Development Account)

Under supervision of Hon'ble LG, DDA introduced a number of measures to enhance customer experience and boost the sale of housing units. The token money was substantially increased to attract only serious buyers, from lottery system, the mode of allocation was changed to first come first serve/e auction, which gave buyers their choice of flats. Besides, Housing regulations were amended, removing the restriction of owning a property in Delhi for applying in DDA Housing Scheme. In addition to these a professional marketing strategy adopted by DDA for the first time, also helped the sale. Single window enquiries on web site, seamless information to buyers and handing over all property related and ownership documents to the buyer helped generate customer confidence and trust towards DDA.

he PM-SVANidhi Scheme of the Government of India, aimed at providing bank finance to Street Vendors was effectively sabotaged by the then Government of NCTD. Despite there being a massive demand on part of the Street Vendors and extremely good loan repayment compliance, it was said that there is no appetite for the Scheme.

Hon'ble LG, who met many delegations of Street Vendors ensured that the Scheme was implemented in letter and spirit. That the Scheme had gained massive momentum was visible, when more than 50,000 beneficiaries gathered at the JLN Stadium to receive their loan cheques from the Hon'ble Prime Minister of India. Till now, more than a lakh of Vendors have availed of this scheme.







XXIII. AARAMBH LIBRARY

fter the tragic death of three civil services aspirants in July 2024 due to flooding in the basement of a study centre in Old Rajendra Nagar, Hon'ble LG had met the students and promised them a safe and secure environment to study.

He assigned this responsibility to DDA, directing them to create 24x7 libraries with dedicated reading space and adequate infrastructure at affordable charges. 

A GRATIFYING JOURNEY FULL OF CHALLENGES

My Dear Fellow Residents of Delhi,

Three years ago, Hon'ble Prime Minister, Shri Narendra Modi, chose someone with a humble background as mine for the august office of Lieutenant Governor of Delhi. I felt the weight of the enormous responsibility and the burden of history on my shoulders. I took a solemn vow to uphold the confidence which was reposed in me by Hon'ble Prime Minister. On the very first day, I resolved that I will do justice to this role by acting as a Local Guardian of the people of Delhi, instead of a ceremonial Lieutenant Governor. Each day over the last three years, I have reminded myself of this solemn promise and tried to uphold it.

It has truly been a gratifying experience for me, a journey of a lifetime. During this period, I made a humble attempt to lend voice to your suffering, to safeguard your interests and to work for your welfare. I have been a grateful recipient of the generous love and affection which has been showered upon me by all of you. This publication is a modest attempt to present a snapshot of some of the landmarks of this special journey over the last three years, which I had the privilege of sharing with you.

Delhi has a unique governance structure. The Constitutional scheme of things in Delhi envisages the Lieutenant Governor to play a certain role, leaving the rest to the elected government of the day. Successive governments in Delhi have maintained a harmonious balance of governance which has served the people well. In recent years, people of Delhi witnessed an extraordinary situation.

The very people they elected to represent them in the Legislature, were at war with the Constitutional head of their own government. An atmosphere of perpetual hostility prevailed against the Central Government and the neighbouring state governments, undermining the spirit of cooperative federalism. At the slightest pretext, the elected government filed cases against its own Lieutenant Governor, demanding that he be prevented from working in public interest.

Civil servants felt besieged. In an unprecedented move, ministers routinely filed cases against their own Secretaries in Hon'ble Supreme Court and the High Court. I was reminded of the words of Sardar Patel, when he addressed the Constituent Assembly and said, "Do not quarrel with the instruments with which you want to work. It is a bad worker who quarrels with his instruments." Here was a government fighting with its own machinery.

A vituperative and slanderous campaign was launched, targeting me and my family personally, to dissuade me from discharging my obligation towards you, but I remained undeterred.

It saddened me to see how popular mandate is frittered away in the pursuit of blind personal ambition and how precious public trust is lost. A government which secured popular mandate on the plank of probity, lost its way in the pursuit of greed. The blinding arrogance of power became a license to disrespect any institution and disregard all conventions. On several occasions, I cautioned those in charge, that great power comes with even greater responsibility, but my words went unheeded.

Whenever I ventured out in the city, I felt pained to see the plight of its residents, especially the poor who subsisted in absolute squalor. Mounds of garbage had become mountains of shame. A sacred river had turned poisonous with monumental neglect. Toxic winter air left people gasping for breath. People struggled to get clean drinking water, even as the neighbourhood drains drowned the roads. The drains were so choked that a monsoon shower could flood the entire city.

It was very difficult for me to remain a bystander and watch a glorious city fall in such rapid decline. As your local guardian, I walked the roads and by-lanes of the city to engage with you and to understand your sufferings. It became evident to me that unless I step in to stem the rot, the city would fall apart.





I did my bit to galvanize a dispirited official machinery. Over the last three years, I met thousands of common citizens at Raj Niwas and during my field inspections and visits to project sites. People poured their anguish and frustration. They were also generous with their appreciation when they saw change on ground. This bred insecurity in the minds of those holding positions of political power. My secretariat was paper logged with an avalanche of frivolous litigations, filed against me by my own government. Perhaps it was a deliberate design to thwart my efforts to serve public interest.

While many thought that occasionally, I went beyond my remit, but for me, these were extraordinary times that warranted extraordinary measures. Public positions are held in solemn trust. The powerful words of Mahatma Gandhi have served as my guiding light- "The best way to find yourself is to lose yourself in the service of others."
